#### CHAPTER I

#### INTRODUCTION

# **1.1** Background of the research

English is a universal language because it is used as the primary language in most countries in the world. In addition, English is one of the important international languages to be studied. Some countries, especially former British colonies, have adopted English as their second language to learn after their mother tongue. The Ministry of Education and Culture (Kemendikbud) has issued Circular Letter Number 15 of 2020 concerning Guidelines for the Implementation of Learning from Home in an Emergency Period for the Spread of Covid-19. Expert Staff of the Minister of Education and Culture for Regulation, Chatarina Muliana Girsang conveyed this Circular Letter Number 15 to strengthen the Circular Letter of the Minister of Education and Culture Number 4 of 2020 concerning the Implementation of Education in the Coronavirus Disease (Covid-19) Emergency Period.

The Minister of Education and Culture emphasized that online/distance learning is carried out to provide a meaningful learning experience for students, without being burdened with the demands of completing all curriculum achievements for grade promotion and graduation. "We would like to recommend for areas that are already learning from home to ensure their teachers also teach from home to maintain teacher safety, that is very important," said Nadiem.

Online/distance learning is focused on increasing students' understanding of the corona virus and the Covid-19 outbreak. Learning activities and assignments may differ between students, according to their respective interests and conditions, including in terms of access gaps/learning facilities at home. Evidence or products of learning activities are provided with qualitative and useful feedback from the teacher, without being required to provide quantitative scores/values. "Although

many schools implement learning from home, it does not mean that teachers only give assignments to their students. But also interact and communicate to help students do their assignments. Please, even though you are working from home, please guide our students too," explained the Minister of Education and Culture. We are currently and continue to collaborate with various telecommunication companies to provide data subsidies for students and teachers who do online learning," he added.

Because students are required to study from home, media or tools are needed to support learning where this learning is known as E-Learning, namely structured learning with the aim of using electronic or computer systems so that it can support learning. Process (Michael, 2013:27). E-learning is an educational system or concept that utilizes information technology in the teaching and learning process. Here are some definitions of E-learning from various sources: Distance learning process by combining principles in the learning process with technology (Chandrawati, 2010). The learning system used as a means for the teaching and learning process to be carried out without having to meet face-to-face between teachers and students (Ardiansyah, 2013).

Through the method of learning English with E-learning, students actively seek information, do assignments, and collect assignments in the form of text, images and videos that are distributed in various E-Learning media. This is of course with feedback from the teacher as an appreciation and motivation for SMK TARUNA BALEN students in participating in the E-learning learning process. This is certainly a new experience for SMK Taruna Balen students which they usually learn face-to-face with their teachers. In the last 2 years they have to study at home and have to study online so they study in person. Of course, conditions like this become an obstacle in the teaching and learning process. All of that must be passed by the SMK Taruna Balen students and they have to get used to new things, such as E-learning. Where learning is almost mandatory for all students in Indonesia, including SMK Taruna Balen students. Especially in English learning. Before covid hit their beloved country, students learned English face to face with teachers, because the covid case in Indonesia is getting worse every day they have to learn

English from home online where online learning requires media to support the English learning they are currently living.

Technically, students can operate applications such as Google Classroom and Whatsapp groups. However, in practice, the learning objectives have not been achieved. Therefore, the researcher analyzed the experiences and difficulties of students in learning English using e-learning media, so that the learning objectives went well. This can be seen when researchers conduct preliminary research on WhatsApp media. The interaction uses synchronous communication. The researcher took data from several random students from the school. The results show that students have negative experiences and have difficulty understanding in learning. This means that the indicators of learning objectives have not been met. This study aims to find out how the experiences and difficulties of students in learning English using online learning media (e-learning). The difference between this research and previous research is that some previous research was conducted during pre-pandemic conditions and learning was still carried out offline, but the research conducted by this researcher was carried out after students experienced online learning several years ago.
