# **CHAPTER I**

# **INTRODUCTION**

#### 1.1 Background of the research

To express his feelings, we need to use conditional statements. For example, if my parents had money, I would buy a dictionary. Conditional clauses are one of the things you need to learn in grammar to achieve proper sentence formation. Based on the explanation above, the writer is interested in analyzing the acquisition of conditional sentences in the second grade. Proficiency is a way of determining

students' ability to master grammatical forms, especially conditional clauses. Student errors can be caused by the inability of students to understand conditional sentence. In this study, the authors focus on analyzing the level of conditional proficiency in students. (Septialindar & Sujati, 2009)

Many people can't express anything through conversation with each other. People need to understand that conversations are meant to convey messages. As stated by Nikitina (2012, p. 13), "Writing is not always an easy task, because written messages do not carry audible or non-verbal signals like spoken language." Writing needs to be mastered by students. To write well, you need to learn grammar. Grammar is one of the sub-skills that support writing. As Scrivener (2003, p. 252) points out, "learning grammar" plays a central role in students' expectations for language learning. Grammar refers to the rules for sentence formation, word forms, and verb patterns. This is a problem for students studying EFL. One of the many grammatical items is the conditional clause. (Adela, Suharti, & Hanim, 2020)

Teaching grammar in Indonesia is not easy because the terms in English and Indonesian are different. Learning grammar is not easy, so this essay tries to offer two different approaches: a deductive approach and an inductive approach. This approach is used to teach grammar, and the focus of this work is on teaching conditional clauses. Based on the vocational high school curriculum, conditional sentences are taught in the second semester after students complete the mid-odd semester. However, most national exams are grammar tests, so students are required to master grammar. Some grammar is difficult to explain conditional clauses (Gorat & Prijambodo, 2013)

For the reasons above, the author decided to conduct a research entitled "Analysis on Students' Difficulties in Learning Conditional Sentence". This research is important because it contributes theoretically and practically to teachers, students, and other researchers. Theoretically, this research can be used as an additional reference for other authors to further develop other related research. Students can understand it better because it can be used as a reference to briefly explain conditional sentences. In fact, this study will provide an overview of conditional clauses and help understand how to determine the correct format when using conditional sentences. The author hopes that this

research can be useful in the future for the general public, especially for students. (Septialindar & Sujati, 2009)

In the other hand, the problems come when the students face the difficulty in using conditional sentence which is caused by difference grammar between Indonesia and English. Conditional sentence become one of the materials in grammar that difficult and complex to be used by the students especially in senior high school. Conditional sentence even used in daily test, final exam, and national examination. Identified the difficulties of conditional sentence are essential to know how well the students mastery the materials. In response to difficulties such as these, the researcher then analyzes the students' difficulties in using conditional sentence at the tenth grade students of SMK Al-Kyai Sukosewu in the academic year of 2021/2022. The researcher choose SMK Al-Kyai Sukosewu as participants because the eleventh grades students still difficult to understand conditional sentences material in English learning. The participants confuse to make sentence by using conditional sentences form and can not distinguish both of conditional sentences types I, II and III. It cause several problem both of students and teacher in learning process. So the researcher interest to investigate the students' problem.

English is considered cognitively and linguistically complex, and can express different meanings in different ways. Different meanings of conditioned clauses, such as cognitive reasoning, counterfactuals, especially form, meaning, and temporal context, can cause great difficulties in conditional sentences (Nekouezadeh and Bahrani 2013).
